

PROTECTING WATER RIGHTS IN THE ENTIAT RIVER VALLEY

INTRODUCING THE ENTIAT WATER EXCHANGE PROGRAM

As a conservation district, one of our many goals is to ensure that local landowners throughout Chelan County have the knowledge and assistance they need to effectively and responsibly manage natural resources on their property and in their greater community. In keeping with this mission, District personnel have been working with the Entiat Watershed Planning Unit (EWPU) and representatives from Trout Unlimited to develop the Entiat Water Exchange Program.

If landowners wish to see the Entiat Valley remain a viable agricultural community, water rights need to be kept intact to support that option.

CONSERVATION WITH YOU, THE LANDOWNER, IN MIND

Riparian restoration is the planting of native vegetation along or near the banks of rivers, streams, and other bodies of water. It may also include re-shaping or stabilizing the bank where there are threats of excessive erosion. Riparian habitats are important to our waterways and ecosystems because they prevent erosion, recycle nutrients, filter pollutants, reduce downstream flooding and are home to a variety of fish and wildlife species. Cascadia Conservation District has been working with landowners throughout Chelan County on a variety of riparian restoration projects.

Specifically, the District has been partnering with Entiat River streamside property owners to transform the lower Entiat River into a more fish-friendly

The Exchange Program was established in response to current state laws that mandate if you do not use all or portions of your water right for a period of five successive years and do not have a legally accepted reason for not using the water, your right is subject to relinquishment. Under relinquishment, all or part of your

water right can be permanently lost. So if, for example, you ever decided to cut back on the amount of acres you irrigate, or you choose to convert from one crop to another and do not continue irrigating at the same rate, you may lose your water right. In addition, any right transferred out of the Entiat watershed is permanently lost, which could have negative effects on current and future landowners who need to irrigate orchards, pastures, and gardens. If landowners wish to see the Entiat Valley remain a viable agricultural community, water rights need to be kept intact to support that option.

Once you are ready to access your right again, or transfer it to another person, you can withdraw it from the Exchange knowing that the right will still have the original priority date and the same quantity of water.

PROJECT CONNECTS LOCAL COMMUNITY & THE ENVIRONMENT

The Upper Wenatchee Watershed Stewardship Project is a partnership between the Ponderosa Community near Plain, Chelan County Natural Resources Department, Cascadia Conservation District, and Trout Unlimited.

Funding for the project is provided by a grant from the Community Salmon Fund, which is a partnership between the National Fish and Wildlife Foundation and the State Salmon Recovery Funding Board. Project goals include promoting education, watershed stewardship, and conservation practices amongst the 450 Ponderosa Community residents living along 1.5 miles of Wenatchee River waterfront.

Doug Pendleton, the chair of the Ponderosa Community Watershed Committee, was instrumental in developing the project. Pendleton, who has a background in environmental education, described how the idea for the project came about. *“Our community wasn’t paying attention to the*

river, which isn’t in line with our mission”, said Pendleton. *“Our mission is to live in harmony with the environment and in order to achieve our mission we needed a plan and guidance, so I reached out to various organizations.”* Pendleton hopes that through participation in education and outreach

efforts, community members will gain a better appreciation for their natural environment and adopt conservation practices that will preserve the area for future generations of community members, visitors, and sportsmen.

Some of these education and outreach efforts are well underway. The District will be hosting a “Families in the Creek” event to encourage residents to explore their watershed and roles as stewards. The Wenatchee River Clean-up will also be expanded to include areas near Plain.

Trout Unlimited will be working with Ponderosa Community members to evaluate water use and to educate residents about how they can conserve water. The goal of this outreach effort is to ensure

that future development in the area can still be supported by the existing group water system. In addition, Chelan County Natural Resources Department staff members have been working with Ponderosa residents to document the current condition of shoreline habitat.

habitat. So far, over 16,000 linear feet have been restored along the river since fall 2007. During that time, these projects have expanded in complexity and scope due to experience, increased funding, new techniques, and increased landowner participation. None of these projects would be feasible without the support of landowners, work crews, and volunteers who have invested countless hours of hard work.

Aside from improving habitat and the quality of our waterways, these projects are also focused on helping landowners achieve their conservation goals. This fall, Resource Specialists from Cascadia Conservation District have been working with landowners in the Entiat and Wenatchee Watersheds on a variety of restoration projects.

Patrick Diehm, whose family owns and operates Mom and Me Farm, decided to collaborate with the District because they wanted to help wildlife and improve the quality of their land. Diehm described the work and partnership with the District as a win-win saying, *“Restoration projects*

are about enhancement - enhancement for us and wildlife. Landowners should take a closer look at these programs instead of turning them away. They’re a good thing.”

The Exchange Program provides participants with a means to protect their water right. You can decide how much is reserved and when or if it will be needed in the future. By transferring rights to be held in the Exchange, water remains instream and the right to use it is protected from relinquishment. Once

you are ready to access your right again, or transfer it to another person, you can withdraw it from the Exchange knowing that the right will still have the original priority date and the same quantity of water.

If you are a water right holder in the Entiat River valley please consider the Entiat Water Exchange. Whether you are thinking about reducing the

amount of water you use to irrigate your land, or you are considering selling your right and transferring it downstream, we can help. There are a number of options for transferring or even selling your right to the Exchange, so that it remains instream and available to you, or future landowners, for use.

2011 NATIVE PLANT SALE

ALSO OFFERING FREE "NATIVE PLANTING 101" WORKSHOP

Cascadia Conservation District is now accepting orders for our annual native plant sale. This year we will be offering fifteen different plant species suitable for a variety of planting projects.

Our plants are available as bare root stock, meaning they do not come in pots or burlap bags. They are harvested from the field in winter when the plants are dormant and arrive ready to be replanted in your landscape.

We offer our plants in bundles of 10 stems with the exception of the Ponderosa pine, and the upland and riparian mix options. The Ponderosa pine are available in either bundles of 25 stems or bags of 200 stems. The upland or riparian mixes include 5 stems of each of the four associated plant species for a total of 20 stems per mix. An order form is included below. A brochure with color photos and information on each of the plant species we are offering is available by calling our office at (509) 664-9370 or by visiting our website at www.cascadiacd.org.

All orders must be received by February 1, 2011. Plants are sold on a first-come, first-served basis and quantities are limited. A minimum 50% deposit is required to hold your order. Fully prepaid orders are

greatly appreciated. Unfortunately we are unable to accept credit cards at this time.

When completing your order form, please select one of the two available pick-up dates. Plants will be distributed at the Stemilt Growers Warehouse in north Wenatchee. A map to the pick-up site will be sent to you along with your receipt as your selected pick-up date approaches. Please be aware that any unclaimed plants will be considered abandoned and used for conservation projects. There are *no* refunds for plant orders not picked up.

In addition to the plant sale, we are also sponsoring a free workshop titled "Native Planting 101." The workshop will be held on January 15, 2011 from 2-4 pm, in the Chelan County PUD auditorium at 327 North Wenatchee Ave in Wenatchee.

"Native Planting 101" will cover a wide variety of topics including how to prepare your site for planting and planting for success. The workshop will also feature local native plant expert and owner of Derby Canyon Natives, Ted Alway, as a guest speaker. Stock Types

1-0 hardwood (1-0)

Grown in seedbed for one year and typically range in size from 8-18". They represent the smallest stock type and therefore the easiest to plant correctly, however, they are more easily choked out by competing vegetation so plan for weed control.

2-0 seedling (2-0)

Grown two years in seedbed and typically range in size from 18-60". They are bigger and better able to compete with surrounding vegetation and withstand light to moderate browsing by wildlife.

plug-1 transplant (P-1)

Grown for one season in greenhouse then transplanted into ground for one season resulting in larger root system. Most survivable and vigorous stock type.

cuttings

Unrooted 36" cuttings, or "live stakes". Very easy to plant, often requiring a tamping bar of some sort to create a hole.

Registered voters residing within the Cascadia Conservation District boundary* who are interested in guiding conservation efforts in Chelan County are encouraged to run for office. Board members are unpaid volunteers who serve a three-year term and must be available to attend monthly meetings.

To announce your candidacy...

1. Obtain an information form and nominating petition by calling our office (509) 664-9370 or visiting our website at www.cascadiacd.org.
2. Collect signatures from 25 registered voters in the District.
3. Submit completed information form by December 22, 2010. Include the nominating petition to get your name printed on the ballot.

* The Cascadia Conservation District boundary currently includes all of Chelan County except for the incorporated cities of Wenatchee and Chelan.
