Even with all of my husband's orchard savvy, he had to find another job this year and we had to find ways for the orchard to survive and thrive. We are not alone. Many of you are hustling, too.

We have all had to progress this year. A lot. Between a global pandemic, multiple years of production/quality loss and crazy weather ‘events’, it has been hard. If you are reading this I hope you know how amazing you are and that you should be proud of what you have accomplished in the face of such trials.

*One way our farm had decided to battle these changes is to seek the wisdom and financial help of those who are champions of conservative practices.*

We need to be conservative with our water. Doing this increases the quality of fruit and stretches our water further. Win, Win!

*Through Cascadia's grants we have been given the opportunity to track moisture levels through technology, change our sprinklers from old rainbirds to micro's and to install drip for areas of high wind.*

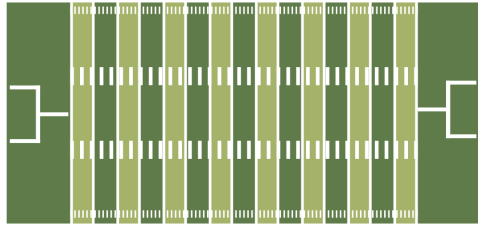

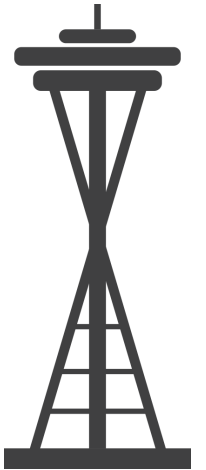
# BY THE NUMBERS

## PROGRAM HIGHLIGHTS FROM 2020

**30** acres of thinning for forest health improvement with our cost share program  
= over **23** American Football fields



Installed **700** feet of new livestock exclusion fencing = more than the height of the Space Needle



Installed 8 beaver dam analogs to restore almost **2,000** feet along Chumstick Creek = that's over half the length of the Interstate Bridge between WA and OR



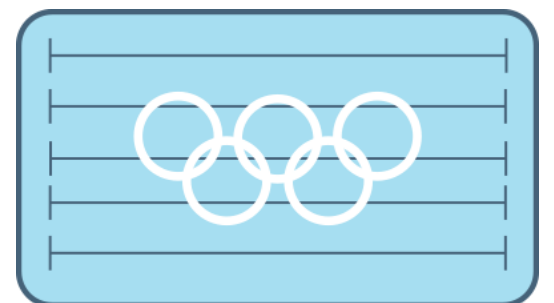
Planted **2,000** native plants and shrubs over **5.5** acres and educated **50** community members at our Native Planting 101 workshop



Four producers worked with Cascadia to become certified in the Salmon Safe program, for over **600** acres of apples, cherries, blueberries, raspberries, vegetables, flowers and herbs = almost the size of the entire WSU or UW main campuses

Via the WSU pear fruit quality study, four landowners upgraded their irrigation systems (timers, moisture probes, efficient sprinkler heads) on over **60** acres of orchards and berries, improving fruit quality and saving millions of gallons of water .

Each **660,000** liquid gallons saved equals one Olympic sized swimming pool



Roving Chipper programs treated **113** forested acres on **168** private properties throughout Chelan County.



**20** soil tests were performed, which resulted in three Water Quality plans

Even with school closures and instruction restrictions, we reached **561** students directly through in-person or virtual Wheat Week, Kids in the Creek, Kids in the Forest, Salmon Festival, and After School Programs.

While nothing replaces the in-person, hands-on aspects of our programs, with the creation of our virtual materials we have the potential to reach an indefinite number of teachers and students across our state, country, and beyond.

**Hundreds** of teachers, environmental educators, and students have already accessed these virtual materials with many more to come.

...TO JOIN OUR BOARD OF SUPERVISORS...

Cascadia Conservation District is self-governed by a Board of Supervisors who work to establish priorities, set policy and direct the work of Cascadia staff. Registered voters residing in Chelan County who are interested in guiding local conservation efforts are encouraged to run for office.

Board members are unpaid volunteers who serve a three-year term and must be available to attend monthly meetings. The time for filing to run this year has passed, but an appointed position is also open for application through March 31. Candidates must be registered voters residing in the conservation district, and may be required to own land or operate a farm.

**A poll-site election for a seat on the Cascadia Conservation District Board of Supervisors will be held on February 5, 2021 at the Pybus Public Market, 7 N Worthen St, Wenatchee. Polls will open at 11:00 am and close at 4:00 pm. Registered voters who reside within Chelan County are eligible to vote.**

## SHOP SALMON SAFE

For the past year, Cascadia has been working with local farmers to earn a new eco-label and become Salmon Safe certified. This program certifies farmers who are implementing farming practices that protect water quality, maintain watershed health and restore habitat.

There are hundreds of certified West Coast farms, including new Chelan county based farmers. Next time you are at the store or farmer's market look for the Salmon Safe logo (example to the right), and know that you are supporting agricultural practices that protect water quality and help restore fish and wildlife habitat.

**See tips below to help you reduce your risk of wildfire damage:**

- Clear leaves and other debris from gutters, eaves, porches and decks.
- Remove dead vegetation and other items from under your deck or porch, and within 10 feet of the house.
- Wildfire can spread to tree tops, then jump quickly from tree to tree. Prune trees so the lowest branches are 6 to 10 feet from the ground.

# KIDS CORNER

## Fire Drills are Not Just for School!

We have all experienced fire drills at school, but what about at home? Would you know what to do?

*Having a fire drill and a fire evacuation plan at home provides the peace of mind your family needs to know what to do in an actual emergency. We all want our families to be safe and to get out quickly in an emergency, and a good fire evacuation plan and drill will help you feel less worried because your family will be prepared.*

We all live in different sized buildings, such as one- or two-story houses, or small or tall apartment complexes. Wherever you are living, you need to know you can get out safely.

There are several things to consider when creating your fire evacuation plan, such as:

- How many rooms are there in your home and how many exits out of each room?
- How many exits are there out of your house or apartment and where are they located?
- You will want to write down the best ways to get to stairways and other emergency exits and have alternative routes established in case those exits are blocked.
- After exiting your house or apartment you will need to have one place where everyone has decided to meet, such as the front yard or a neighbor's yard.
- Make sure someone in your family is assigned to call 911. If emergency services arrive as soon as possible, there is a better chance of saving your home and staying safe.

To get started creating your own fire evacuation plan, get a blank piece of paper and draw a map of your house using the instructions at the link below, and include the items listed.
