

Thin-leaf alder and black cottonwoods are now providing a shady canopy over the creek, which will keep the water cool in summer.





Larvae of alder flea beetles are munching on leaves turning them brown. This does not happen every year, and is not concerning.



Mountain Home Creek as seen under the leafy canopy in 2014



#### Important Notices

Fire in the Aftermath is a digital slide show produced by John F Marshall of John Marshall Photography through Columbia Breaks Fire Interpretive Center. The major components of the project are repeated landscape photographs from locations known as photo points. The majority of photo points images were produced under contract to the federal government, and are therefore in the public domain. However, the arrangement in this presentation is not a public work, and comes under the protection of U.S. copyright law. Additional photographs were produced independently by Marshall or with the support of Wenatchee Valley Museum and Cultural Center, and Icicle Fund.

Permissible use of Fire in the Aftermath, is presentation in public places, educational settings, and on personal computers and electronic devices. Individual picture files may be displayed in the same manner as the program in it's entirety. Students may print out individual picture files for required projects. Individual teachers may use all or parts of Fire in the Aftermath to prepare lessons in the classroom. Uses that are not permitted except through permission from John F Marshall are posting on internet sites, and incorporation of all or parts into new and separate projects for use at more than one location.

#### For Optimum Display

Fire in the aftermath has been formatted to fit wide (16:9) aspect ratio screens, that are capable of showing ultra-high definition (3800 x 2160) images. For best viewing one of these screens is to be used. High definition (1920 x 1080) screens may also be used but will deliver a lesser result. Viewing on personal computers or tablets will also work, but it won't be possible to see the whole image at maximum resolution. Mediocre display will occur with the use of most digital slide projectors.
