UCSRB is requesting project info.

Kari – Gave a brief report on the updated assessment. Mad Roaring Mills Assessment – lower Entiat in the Mad/Roaring/Mills watersheds. Fuels reduction work, restoration, stream restoration on Mad and Roaring creeks. Improvements to road system. The draft is different than what has been done in the past.

Tillicum area, tree thinning over the years. Got partnership with DNR to do 3,000 acres of thinning. Will see a lot of contractors cutting small trees in that area.

The Yakama Nation's Silver Falls Campground project will have helicopter placement of wood this summer. Folks' up valley will be able to see the work.

Send landowners to Kodi Jaspers with any beaver issues.

Alex – just started last week. Working in Wenatchee watershed, tying in with Entiat. Excited to be here.

Renee – discover Entiat, up Entiat river trails. Would like to put out to all agencies. Help us to preserve and keep the area pristine. Let's educate people ahead of time. Lot of people in the woods that don't know what they are doing. Any info can give Renee a heads up.

Chris – river mile 24 up to the Silver Falls will be closed. I will keep in communication with you.

Mark – would like to change one word – transform conflicts - instead of - avoid conflicts. Conflicts can be a path for progress. Recreation is a valuable piece of the valley.
