
CASCADIA RESPONDS TO HISTORIC WIND STORM DAMAGE IN LEAVENWORTH

In December 2025, Cascadia partnered with City of Leavenworth to help landowners remove debris from a historic wind storm that caused significant damage in the Leavenworth area.



Eight Cascadia staff and 60 volunteers chipped over 1,000 cubic yards of material that was blocking roads, alleys, driveways and snowplow operations. Thank you to all the hard work from residents, organizations, and volunteers!

Many groups of volunteers spent the weekend helping residents remove trees from roofs, cars, and restore access on streets and driveways. Cascadia coordinated with the crews and followed behind chipping material. FIRST ORCHARD BIOCHAR WORKSHOP A SUCCESS

On December 10th, Cascadia hosted our first Orchard Biochar Workshop. While we've held biochar workshops in the past, this was our first with a focus on agriculture. Even though the forecast looked crummy leading up to (and following) the day, we ended up with nearly perfect weather for a great event.

Thanks to strong community interest and funding from the Washington State Conservation Commission, we've already scheduled the next workshop for **March 20th** in Cashmere. Did you know?

Biochar improves water quality by acting as a natural filter, adsorbing excess nutrients (like nitrogen and phosphorus) and contaminants (heavy metals, organic pollutants) from runoff and wastewater, reducing eutrophication and preventing pollution of groundwater and streams, while also enhancing soil's water retention and infiltration.

RIVERSCAPE PROGRAM CONTINUES TO GROW

Across all of Chelan County, 3 different watersheds, and 41 distinct properties, CCD staff was able to meet restoration goals set for the 2025 field season. In the Spring, field crews from CCD, Washington Conservation Corps, and contractors with Ecological Services performed maintenance on roughly 220 previously installed beaver dam analogues (BDAs) along Chumstick Creek and its tributaries. In the summer, CCD, in partnership with Cascade Fisheries, led projects.

The restoration working group completed construction of 177 new in-stream structures consisting of BDAs and post-assisted log structures (PALS). These structures mimic beaver complexes that retain water in our systems for longer and provide critical habitat for fish and wildlife. Implementation of these structures requires hundreds of untreated posts and are labor intensive as they are hand built.

Program Highlights from 2025

AGRICULTURE

- \$45,815 reimbursed across eight cost-share projects
- 1.9 million gallons of water conserved annually (that's 2-3 Olympic-sized swimming pools)
- 9.1 tons of erosion sediment reduced per acre yearly (roughly the capacity of a standard dump truck)
- Provided technical assistance to 100+ people
- 55 farm plans developed


